

**Assessment Application for a Regional

**For:** Westside proposes to undertake exploration activities (a seismic survey). Part of the survey area is located within the Moura Priority Living Area (PLA). The PLA is an area of regional interest under the Regional Planning Interest Act 2014 (Act). The Act requires a Regional Interests Development Approval for undertaking resource activities within the PLA, including for exploration activities. Seismic surveys are used to map the sub-surface structure and involves initial surveys, minimal clearing of the seismic lines (stick raking or slashing) if required and using vibrating plates and geophones to record the reflection of sound waves. The activities will take a few weeks in total. Seismic surveys are a low-impact activity and will not cause any long-term surface disturbance to land. The total disturbance within the PLA associated with the activities is zero.
